RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

**Name of Activity or Event: Scooters 4 Hooters Annual Legacy Ride
March 24, 2012**

The undersigned hereby agrees to comply with all rules and regulations for all activities for participation. IN CONSIDERATION of being permitted to perform, or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, THE UNDERSIGNED, personal representatives, heirs, and next of kin, acknowledges, agrees and represents that the undersigned has, or will immediately upon entering the location, and will continuously thereafter, inspect such locations and all portions thereof which the undersigned enters and comes in contact with, and does further warrant that entry area or areas and participation in the event constitutes an acknowledgement that the undersigned has inspected such area and finds and accepts the same as being safe and reasonably suited for the purposes of use, and further agrees and warrants that if, at any time, is in or about areas and feels anything to be unsafe, the undersigned will immediately advise the officials of such and will leave the areas:

1. THE UNDERSIGNED expressly acknowledges that participation is voluntary, agrees that the activities of the event are dangerous and involve the risk of serious injury and/or death and/or property damage, by participating the undersigned expressly assumes any and all risks of injury or loss, and further expressly agrees that the forgoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Florida in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the event organizers, the Contest Organizers, and any persons in any area, officials, directors, employees, and agents, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, all for the purposes herein referred to as "releasees" from all liability to the undersigned, personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the area, and/or, performing, competing, officiating in, observing, working for, or for any purpose participating in the event.

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

4. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participant in the event. THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

I UNDERSTAND I ASSUME ALL RISK INHERENT IN MY PERFORMANCE and PARTICIPATION IN the Scooter Ride.

I VOLUNTARILY SIGN MY NAME EVIDENCING MY ACCEPTANCE OF THE ABOVE PROVISIONS and WARRANT THAT I AM AT LEAST EIGHTEEN (18) YEARS OF AGE.
